

Modern Slavery Policy

Overview

Modern Slavery is a crime and violation of human rights and is defined under the Australian Modern Slavery Act 2018 (the Act) as including eight types of serious exploitation:

- trafficking in persons;
- slavery;
- servitude;
- · forced marriage;
- forced labour;
- debt bondage;
- · deceptive recruiting for labour or services; and
- the worst forms of child labour which means situations where children are subjected to slavery or similar practices or engaged in hazardous work.

Purpose

The purpose of this policy is to illustrate Ambrose Construct Group's commitment to ensure to the best of our ability that there is no modern slavery in any part of our business operations. We are committed to acting ethically and with integrity in all business dealings and relationships, and where possible, to ensure modern slavery is not taking place in our own business or supply chain consistent with the Group disclosure obligations under the Act.

Scope

This policy applies to all persons working for and with Ambrose Construct Group or on its behalf in any capacity, including employees, directors, officers, external consultants, third-party representatives and business partners.

For the purpose of this policy, Ambrose Construct Group relates to the group of companies operating under Insurance Building Australia Holdings Pty Ltd, the ultimate parent company and 100% owner of Ambrose Construct Group Pty Ltd, Inserve Australia Pty Ltd T/A Construct Services, Marshall Restorations Pty Ltd, FEN Australia Pty Ltd, Xtreme Clean Sanitisation & Restoration Pty Ltd, Collective Trade Services Pty Ltd and Scope IT Services Pty Ltd (collectively, the Group).

















Commitment

Ambrose Construct Group is committed to sustaining a Modern Slavery program:

- that limits the risk of modern slavery occurring within the business, by ensuring there is transparency in our approach to tackling modern slavery throughout our supply chain.
- where our employees and suppliers have a shared commitment, to ensuring modern slavery does not exist in our business or our supply chain.
- that promotes ethical business practices that protects employees from being abused or exploited within our business and our supply chain.
- that actively identifies risks of Modern Slavery within the business and our supply chain, providing a pathway for these risks to be reported without recrimination.
- that regularly monitors our supply chains operations ensuring they are aligned with our own business requirements while taking action where necessary to terminate engagements.
- that regularly reviews our procurement agreements and processes ensuring the Group are in line with all Modern Slavery compliance requirements.

Approval

This Policy was approved by the board of directors of Insurance Building Australia Holdings, being the principal governing body of the Group (**Governing Body**).
